AMENDMENT TO
DECLARATION OF COVENANTS,
RECORDED BOOK 1137, PAGES 147
ET SEQ., DURHAM COUNTY REGISTRY

THIS AMENDMENT, made this 8th day of December, 1985, by the undersigned, hereinafter referred to as the "Lot Owners", to the Declaration of Covenants, Conditions and Restrictions dated November 14, 1983, and recorded November 14, 1983, in Book 1137, pages 147 et seq., Durham County Registry, hereinafter referred to as the "Declaration".

#### WITNESSETH:

WHEREAS, the Declaration contains easements, restrictions, covenants and conditions upon certain real property located in Triangle Parkwood West Fire District Township, Durham, North Carolina; and

WHEREAS, the Declaration provides, pursuant to Article XII, Section 3, that the Declaration may be amended by an instrument signed by not less than ninety per cent (90%) of the Lot Owners; and

WHEREAS, the undersigned constitute not less than ninety per cent (90%) of the Lot Owners of the real property subjected to the Declaration, as amended; and

WHEREAS, the undersigned Lot Owners desire to amend Article IV, Section 10, as hereinafter set forth.

NOW, THEREFORE, pursuant to Article XII, Section 3, of the Declaration, Article IV, Section 10, entitled <u>Insurance Assessments</u>, shall be amended by deleting the second paragraph thereof and inserting the following:

The Board of Directors, or its duly authorized agent, shall assure that each townhouse is insured against loss or damage by fire, lightning or other hazards, and extended coverage in an amount sufficient to cover the full replacement cost of any repair or reconstruction work in the event of damage or destruction from any hazard, so that the architectural integrity of the project may be maintained and no townhouse left in damaged or destroyed condition because the owner has not obtained insurance. To perform this responsibility, the Board of Directors shall obtain a blanket insurance policy covering all the townhouses with the loss payable to the Association, in which event the premium paid for the blanket policy shall be paid by the Association and included within the annual assessment as a common expense. In the event of damage or destruction by fire or other casualty to any townhouse located upon the lot, the Associaition shall, with concurrence of the mortgagee, if any, upon receipt of the insurance proceeds rebuild or repair such damage or destroyed portions of the townhouse to as good condition as formerly.
